OFF-LICENCE

Sections 29 and 114, Sale of Liquor Act 1989

DLA ref: 057/OFF/90/2011

PURSUANT to the Sale of Liquor Act 1989, Black Estate Limited is authorised to sell or deliver liquor on or from the premises situated at 616 Omihi Road, Omihi, *and known as "Black Estate"*, to any person for consumption off the premises and to supply complimentary samples of liquor on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Part 6 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) No liquor is to be sold or delivered on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day. However, a person may sell or deliver grape wine or fruit wine on Easter Sunday if the grape wine or fruit wine is made –
 - (i) on the premises; or
 - (ii) from grapes or fruit harvested from land on which the premises are situated.
- (b) Liquor may be sold or delivered only on the following days and during the following hours:
Monday to Sunday 8.00am to 6.00pm
- (c) The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

THE LICENSED PREMISES

In terms of Regulation 10 of the Sale of Liquor Regulations 1990, the sale or delivery of liquor is authorised in or from the premises generally. The premises, situated at 616 Omihi Road, Omihi, are more precisely identified as outlined in a plan date stamped as received by the Hurunui District Licensing Agency on 9 February 2012.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the double doors from the courtyard is designated as the principal entrance.

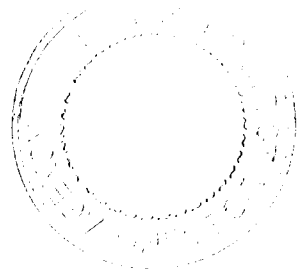
EXPIRATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
